### Course Description

Building on the Introduction to Business Statistics I course, students will deepen their skills in data analysis and decision making under uncertainty using quantitative methods. Emphasis centers on regression analysis, modeling, time series forecasting, nonparametric methods, and statistical process control. Optimization modeling, simulation modeling, and data mining will also be introduced. These tools will be used in the context of business data and examples. This course also has a lab component.

### Expected Learning Outcomes

- Demonstrate knowledge of regression analysis, modeling, time series forecasting, nonparametric methods, and statistical process control.
- Develop a basic understanding of optimization modelling, simulation modeling, and data mining.
- Analyze the advantages and drawbacks of different quantitative methods; demonstrate ability to apply statistical methods in a business context
- Show knowledge of computer-based statistical analysis and Excel spreadsheets, be able to choose and apply right tools while provide their statistical analysis
- Interpret the results of statistical analyses and spreadsheets outputs, draw conclusions to make decisions under uncertainty

## Additional Requirements

All students should have a hand-held, non-programmable calculator capable of performing statistical functions (i.e. able to input a data set and compute mean, standard deviation, etc.). Calculators on smartphones or tablets will not be allowed during tests.

## Course Requirements and Evaluation:

Course grading and evaluation will be conducted according to the following:

Note: During the exams, students will be allowed a page of handwritten, self-created notes. This formula sheet should contain any formulas the student feels they will need during the exams, as well as any comments they feel may assist them. Again, this sheet should be created by the students themselves to assist them both in studying and learning materials, and to assist them during the exams.

To pass the course, students must achieve an overall grade of at least 50%.

There will be 4 assignments as well as the midterm and final exams. All assignments and exams will involve the use of the XLSTAT software which comes bundled with the course textbook. During exams, the students will be expected to limit their laptop use to this software and not utilize any online resources or attempt to discuss problems with each other.

## Submission of Assignments:

Assignments will be posted to the course Moodle Page and be due on dates that will be determined as the semester progresses. As assignments will involve a great deal of software usage, the assignments will be submitted primarily online to specific email addresses that will be listed on the assignments.

## Class Participation and Attendance:

Students are expected to attend all lectures and labs to ensure success on exams, and quizzes. Students not attending lectures may find themselves missing information not covered in the textbook. Any student who is absent for an exam or misses an assignment due date should speak to the professor and, where possible, provide a doctor's note.

Because of the nature of the Alpha 4.00 system, there can be no uniform College-wide conversion scale.
