Course Description

A foundational course in literary studies, this class provides an introduction to a wide range of literary works in English from the eighth century to the late eighteenth century. The course introduces students to the breadth of genres that comprise the English literary tradition. Significant attention will be given to critical reading skills and further development of writing skills.

Expected Learning Outcomes

This course considers many of the most important landmarks of writing in English. These landmarks, though, are not simply sights to be seen or, less metaphorically, texts to be read; rather, they teach us something about how to read and how people have read in the past. Students will thus gain a valuable ground for further literary and humanistic studies, and for becoming more thoughtful, civilized human beings. In particular, diligent students will:

- gain a broad knowledge of English literary authors, movements, and eras from the Middle Ages to the end of the Eighteenth Century and understand the relationship of these to the political, social, and religious history of England;
- gain familiarity with historic English prose styles, the various conventions of closed form English poetry, and the meaning of these forms; and
- consider the intricate relationship of the Christian faith to the literature of this period.

Requirements:

10% Participation and Reading Quizzes

Participation is your visible engagement with the class and the texts: look alert, ask questions, share your thoughts, and visit my office to discuss the course material and your work. Participation requires regular attendance: skip classes and your grade will suffer.

Short reading quizzes will occasionally be inflicted upon you at the beginning of class to ensure that you are keeping up with the course readings.

10% Commonplace Book

Keeping a commonplace book—a topically organized volume of quotations and notes gleaned from and inspired by one’s reading—was standard practice for many educated people in the early modern period. This assignment invites you to do the same, quoting from and musing on course and other readings under a variety of topical headings.

10% Midterm Exam

The midterm exam will cover material studied as of February 17th.

50% Essays x 2

You will write two essays in EN 221, one worth 20% on a topic from medieval literature, and a second worth 30% on a topic from Renaissance or early modern literature. You are required to submit hard copies in class and digital files to Moodle.

20% Final Exam (Friday, April 21st, 1-4 pm, A2133)

The final exam will cover material from the entire course, but special emphasis will be placed on the last third of the course, i.e. on the literature of the Eighteenth Century.

Course Information:

- The classroom is a professional setting. For this reason, I ask that you call me “Professor” or “Dr. Dyck” and I will, in return, call you by the name you prefer. Professionalism is also required in emails. When you email me, please begin with “Dear Professor ...” and, to the best of your ability, use proper grammar and syntax. Also, please check your Ambrose email account regularly.

- Technological devices are distracting and typically don't actually aid learning: put your laptops, tablets, and phones away—unless you and I have had a conversation, and I've approved your use of some of these. (Obviously, this is not applicable to students with specific accommodations.)
- You are responsible for everything said in class, including announced changes to our schedule. If you will miss a class, arrange in advance for a classmate to take notes on your behalf.
- Late assignments will be marked down one refined letter grade per class session late. Essays handed in after the due date will be graded but without grammatical correction or extensive commentary.
- Extensions may be granted upon medical or other compelling grounds but must be arranged for in advance. **No request for an extension made within 24 hours of the due date will be granted** (again, unless there are medical or other compelling grounds).
- In order to receive a passing grade in EN 221, you must submit both Essays 1 and 2, write the final exam, and not miss more than eight class sessions.

Because of the nature of the Alpha 4.00 system, there can be no uniform University-wide conversion scale. Coursework Extensions

Should a request for a time extension on coursework exceed the end of the term, a *Coursework Extension Application* must be completed and submitted to the Office of the Registrar.
